School Description and Mission Statement (School Year 2009-10)

This section provides information about the school, its programs and its goals.

Los Amigos is a 50/50 dual language immersion school in the Palmdale School District. Our goal is to develop students who are able to speak, read, and write both English and Spanish through standards based instruction in both languages beginning in Kindergarten. Half of the students are native English speakers who are learning Spanish, and half of the students are native Spanish speakers and are learning English. All students, regardless of their first language, spend half of their instructional time in each language. We utilize research based, best practices and instructional strategies for all students. By selecting highly trained teachers representing countries throughout the world, our staff is able to insist on rigorous academic standards while providing excellent language models for our students.

Through dual language instruction, students achieve academic success, develop a positive self-image, and attain cross-cultural understanding. Language, culture, and heritage are preserved and respected. Children are taught to value the differences that make them unique and to strengthen the commonalities that draw them together. They come as speakers of different languages, barely able to communicate with each other. Through intentional group learning, they study and grow together through shared work in two languages.

Los Amigos relies heavily on a strong home/school partnership for its success. Parents are encouraged to participate in the School Site Council, the English Learners Advisory Committee, and the Parent Teacher Association. These groups help it plan, review, and refine the dual immersion educational experience.

Parents also are encouraged to volunteer in classrooms and families are expected to be active participants in school activities.

Opportunities for Parental Involvement (School Year 2009-10)

Parents and community members actively participate on the various committees that plan, implement, and evaluate the curricular programs. Los Amigos has the following committees: School Site Council, Parent Teacher Association, English Learner Advisory Committee as well as the School Advisory Committee (SAC).

There are many events that are scheduled for parents and families to attend: Back-To-School Night, to acquaint parents with the instructional program; Open House, to celebrate students' progress; Parent Conference, one time per year to set goals, determine needs, and assess student progress; and school volunteers, to assist and tutor students. Also, families are invited to attend PTSA meetings, multicultural performances, and holiday programs. Los Amigo's goal is for parents to participate in many events a year. The parents will receive written notices and telephone calls to inform them of how they can be involved.

Los Amigos offers remediation and enrichment through extended learning opportunities. GATE students receive a differentiated curriculum according to their GATE IGP's determined through collaborative goal setting effort involving the student, parent, and teacher. EIA/LEP funds support the services of our bilingual aide and our bilingual clerk. We have two resource specialists, two special day class teachers, adaptive PE teacher, a speech therapist, a school psychologist, kindergarten aides, and special education aides that support children with special needs. Los Amigos also provides Classroom that work Kagan Strategies, and supports the BEST program. Title one funding provides additional educational opportunities and materials school-wide.

IX. Student Performance

Standardized Testing and Reporting Program

The Standardized Testing and Reporting (STAR) Program consists of several key components, including the California Standards Tests (CSTs); the California Modified Assessment (CMA), and the California Alternate Performance Assessment (CAPA). The CSTs show how well students are doing in relation to the state content standards. The CSTs include English-language arts (ELA) and mathematics in grades two through eleven; science in grades five, eight, and nine through eleven; and history-social science in grades eight, and ten through eleven. The CAPA includes ELA, mathematics in grades two through eleven, and science for grades five, eight, and ten. The CAPA is given to those students with significant cognitive disabilities whose disabilities prevent them from taking either the CSTs with accommodations or modifications or the CMA with accommodations. The CMA includes ELA for grades three through eight and science in grades five and eight and is an alternate assessment that is based on modified achievement standards. The CMA is designed to assess those students whose disabilities preclude them from achieving grade-level proficiency on an assessment of the California content standards with or without accommodations. Student scores are reported as performance levels. XI. Instructional Planning and Scheduling

Professional Development

This section provides information on the annual number of school days dedicated to staff development for the most recent three-year period.

Teachers meet frequently within and across grade levels in lesson study and grade specific institutes to plan and discuss what they are doing and how to coordinate instruction. A teacher survey is taken at the end of the school year that guides site professional development and in-service selection decisions. Student data is also used to determine professional development offerings. Sites design specific professional development based on academic content standards, the California Standards for the Teaching Profession, and research-based practices.

Educational Services, Special Education, English Learners, Student Assessment and Accountability, and Teacher Support departments participate in the planning and implementation of District staff development activities. Courses are offered throughout the year on week nights and Saturdays.

Trainings are also offered during the summer months on content specific and professional areas such as SIOP, Teacher Leaders, English Language Arts, mathematics workshops, unpacking standards, and intervention programs. . Administration training focuses on the development of learning communities.

Conference and convention attendance, in-service meetings and staff collaboration offers additional opportunities for professional growth. Teachers observe other professionals, engage in peer coaching and work with mentors and grade level or departmental colleagues.
