School Description and Mission Statement (School Year 2009-10)

This section provides information about the school, its programs and its goals.

Description:

The Palmdale Learning Plaza (PLP) is a K-8 School of Choice. Attendance area covers all of Palmdale School District and draws about 60 students from outside the Palmdale School District. PLP has 27 general education and three Deaf and Hard of Hearing (DHH) students in grades pre-K to 8th grade. Additionally, the PLP DHH program serves the DHH community as the site for the Antelope Valley Special Education Local Plan Area (SELPA). PLP is administered by a principal, a half-time assistant principal, a secretary, a half-time bilingual clerk, and a half-time attendance clerk. Additionally, PLP has a full-time LST teacher, a communication speech specialist, a health clerk, a half-time library clerk, two resource specialists, a half-time psychologist, a half-time counselor, a half-time media technologist, and three custodians. The Palmdale Learning Plaza functions with a traditional school year calendar. We have 180 instructional school days. Students in K-8 attend school all day for a total of 360 minutes.

Palmdale Learning Plaza is an authorized International Baccalaureate World School Primary Years Program. At PLP, we strive to create a learning environment that will promote literacy in reading, writing, computing and life skills where all are learners and teachers. The overarching goal is to provide graduates who: cherish life-long learning, are skilled at working collaboratively, and are complex thinkers able to recognize and produce quality products. Further, graduates will recognize and understand the value of contributing to their communities. At PLP, we strive to produce these graduates through instructional delivery using the state frameworks, district curriculum guides, district- adopted, teacher-developed curricular materials and the International Baccalaureate’s inquiry method of instruction. PLP combines an array of innovative instructional strategies used throughout Palmdale’s schools while utilizing tenets from the International Baccalaureate’s inquiry method of instruction, as well as incorporating the concepts of: “community as campus,” “teachers as learners,” and “students as resources.”

Vision:

With parent and community involvement, we offer meaning-centered curriculum emphasizing application and “hands on” learning. Learners demonstrate their mastery with tangible, relevant products which include models, performances, portfolios, exhibits, and major projects. Learners gain an understanding of the value of teamwork through the completion of group projects. We are committed to creating an educational environment that guarantees academic excellence through continuous improvement, self-renewal, and creativity for learners and facilitators.

IX. Student Performance

Standardized Testing and Reporting Program

The Standardized Testing and Reporting (STAR) Program consists of several key components, including the California Standards Tests (CSTs); the California Modified Assessment (CMA), and the California Alternate Performance Assessment (CAPA). The CSTs show how well students are doing in relation to the state content standards. The CSTs include English-language arts (ELA) and mathematics in grades two through eleven; science in grades five, eight, and nine through eleven; and history-social science in grades eight, and ten through eleven. The CAPA includes ELA, mathematics in grades two through eleven, and science for grades five, eight, and ten. The CAPA is given to those students with significant cognitive disabilities whose disabilities prevent them from taking either the CSTs with accommodations or modifications or the CMA with accommodations. The CMA includes ELA for grades three through eight and science in grades five and eight and is an alternate assessment that is based on modified achievement standards. The CMA is designed to assess those students whose disabilities preclude them from achieving grade-level proficiency on an assessment of the California content standards with or without accommodations. Student scores are reported as performance levels. XI. Instructional Planning and Scheduling

Professional Development

This section provides information on the annual number of school days dedicated to staff development for the most recent three-year period.

Teachers meet frequently within and across grade levels in lesson study and grade specific institutes to plan and discuss what they are doing and how to coordinate instruction. A teacher survey is taken at the end of the school year that guides site professional development and in-service selection decisions. Student data is also used to determine professional development offerings. Sites design specific professional development based on academic content standards, the California Standards for the Teaching Profession, and research-based practices.

Educational Services, Special Education, English Learners, Student Assessment and Accountability, and Teacher Support departments participate in the planning and implementation of District staff development activities. Courses are offered throughout the year on week nights and Saturdays.

Trainings are also offered during the summer months on content specific and professional areas such as SIOP, Teacher Leaders, English Language Arts, mathematics workshops, unpacking standards, and intervention programs. . Administration training focuses on the development of learning communities.

Conference and convention attendance, in-service meetings and staff collaboration offers additional opportunities for professional growth. Teachers observe other professionals, engage in peer coaching and work with mentors and grade level or departmental colleagues.
