The Court held that public sector unions may no longer require public employees to pay agency fees without their consent. She remarked that the decision was a long time coming, and has caused upheaval with the State and Legislature. Mrs. Duren stated that the District and local Chapter are working together on a way to implement the decision. She also conveyed that the decision also points further to the Personnel Commission and its purpose to protect classified employees.
