6) COLBI TECHNOLOGIES

Staff from Colbi Technologies discussed a software package for a presentable budget for David G. Millen Intermediate School. Larry Goshorn discussed the history of Colbi Technologies which started in 2002. Grant Vermillion discussed "Bridging the Gap". He discussed 30 standard reports and their web based system. There are reports such as a Project Status Report, Consolidated Budget Status Report, Budget Report, Budget Adjustment Request and Consolidated Cashflow Report.

Support from Colbi Technologies includes the most current software system updates. They presented a slide presentation for data/statistics and the day-to-day decision making.

7) E-RATE AND TECHNOLOGY PROJECTS

Jim Smith, Manager of Information Services discussed the future plans of E-Rate and the Measure DD mission with technology. He presented the committee with a copy of a PowerPoint Presentation titled "Technology Services-2013 Projects" and discussed the current needs of technology (network, phone system, low voltage systems, 20-30 year cabling infrastructure, Common Core, Wifi, Aeries for students, teachers, parents and staff), 21st century classrooms (audio, projection, Wifi and Web 2.0 access devices).

8) UPDATE – DAVID G. MILLEN INTERMEDIATE SCHOOL

Al discussed moving forward with getting approval for water. The annexation has been approved. Local Agency Formation Commission (LAFCO) will be presented as a board item in July, 2013. The Los Angeles County Waterworks District (LACWD) will need a service letter then to LA County Fire then the Division of the State Architect for approval. The project will go out for bid at the end of September-beginning of October, 2013. The project is moving along.

9) UPDATE – SUMMER PROJECTS

The summer projects include Shadow Hills, Los Amigos, Quail Valley, Manzanita, Joshua Hills, Summerwind and Cactus. Trees will be cut down as they are uplifting concrete. We will plant trees to conserve water and hedges will be removed. The district uses 31,000,000 gallons of water a month at a cost of \$400,000 per year.
