 Tamarisk Elementary School, David G. Millen Intermediate School, Prop 39 funds and
 Tumbleweed Elementary School (see handout).
- 6) UPDATE Re-purpose of Juniper Intermediate School AL TSAI AND TRIXIE FLORES Al discussed that we're one year behind in getting this project approved. We need the fire flow test for the Division of the State Architect (DSA) and we are going back and forth trying to get it. Construction should start in February, 2016. \$4.8M will be budgeted for Phase I of Juniper. Juniper will use a lot of DD funds.

11) OTHER - Trixie and Al discussed the "Expenditures by Location 2012-2016" spreadsheets. Trixie indicated that we've received \$40M up to now and have spent \$27M as of the middle of October, 2015. Trixie discussed the spreadsheets by location and object code and a recap of 2012/2013, 2013/2014 and 2014/2015. Back up is available in Trixie's office for review. Trixie indicated that the auditors never found anything that we've missed for DD funds. Al mentioned that the DD language in always referenced in our board items.

Playground projects will be paid from DD funds. The lease with Guidance Charter School at Site 18 will end in 2018 and the lease with The Palmdale Aerospace Academy (TPAA) will end in 2017. We will use Site 12 (TPAA) as an Intermediate School. We will be replacing phone systems at several schools.

Al discussed the Williams settlement funds of \$800M. There will be \$2.3M for flooring and roof repairs (grant application). In 2008, the funds dried up but our applications were approved and aged for seven (7) years. We just received \$8M for 12 schools for miscellaneous projects (roof and asphalt repairs). We will have a consultant help us plan the use of the funds. There will be new technology such as Smart Boards in every classroom (not Tamarisk or David G. Millen Intermediate School).
