Palmdale School District Mission Statement

The mission of the Palmdale School District is to implement our vision with actions and services targeted to students, parents, and staff so our students can live their lives to their full potential. The mission of Chaparral Prep Academy is in line with that of the district. Our mission is to provide each child with a rigorous and relevant academic education, a safe learning environment, and the knowledge, skills, and attitudes necessary for success in the 21st Century and beyond.

Chaparral Prep Academy is a Transitional Kindergarten through 5th-grade school on a traditional school calendar, located in the city of Palmdale, California. Chaparral Prep Academy serves a diverse community and is located in a low socioeconomic area. The student mobility rate is approximately 18% and the actual attendance rate is approximately 93%. The district utilizes a data collection program that interfaces with Infinite Campus, our present data-based student information program, to assist with reducing the lag time of information when a student transfers within the district. This will help to ensure a continuous educational program for transient students. Chaparral Prep Academy houses eight state preschool classrooms on the campus. Access to a state preschool provides an opportunity for articulation between preschool and kindergarten staff, resulting in a stronger, more effective program to start our student's education.

Chaparral Prep Academy is currently using Local Progress Monitoring (LPM) assessments and Common Formative Assessments to periodically assist in driving instruction through the use of data analysis. This data will provide direction to determine the needs for student achievement, which will support learners who struggle as well as students who need challenges through enrichment. Chaparral Prep Academy is also currently using the California Assessment of Student Performance and Progress (CAASPP) online system for state testing with the use of a computer adaptive test called Smarter Balanced Assessment. We are committed to developing Professional Learning Communities and implementing Common Core State Standards to meet the needs of all students. Student academic achievement is our focus. This focus is centered around the five PLC+ essential questions. Where are we going? Where are we now? How do we move learning forward? What will we learn from today? Who benefited and who did not benefit?

2023-24 School Safety Plan

Chaparral Prep Academy is committed to providing a safe environment for students, staff, and community members. We maintain a secure campus with access limited through the main office entrance. The campus employees are provided with a Safety/Disaster Plan and evacuation maps that are instructed on how to handle various safety and emergencies.

Our staff meets frequently to review and address safety concerns, and a site representative attends monthly District Safety Committee meetings. Target Solutions and ALICE Training are also provided for our staff. Safety drills are held monthly to help prepare students and staff to respond to emergencies. The use of the Crisis Go App also helps in communicating among the staff during drills and real-life emergency situations.

Comprehensive School Safety Plan was reviewed and approved by School Site Council on 7 December 2023.

Professional Development

Teachers meet frequently within and across grade levels in lesson study and grade-specific institutes to plan and discuss what they are doing and how to coordinate instruction. A teacher survey is taken at the end of the school year that guides site professional development and in-service selection decisions. Student data is also used to determine professional development offerings. Sites design specific professional development based on academic content standards, the California Standards for the Teaching Profession, and research-based practices.

Educational Services, Special Education, English Learners, Student Assessment and Accountability, and Teacher Support departments participate in the planning and implementation of District staff development. Courses are offered throughout the year on weeknights and Saturdays.

Training is also offered during the summer months in content-specific and professional areas such as AVID, Teacher Leaders, English Language Arts, Mathematics Workshops, and intervention programs. Administration training focuses on the development of Professional Learning Communities and Capturing Kids' Hearts.

Conference and convention attendance, in-service meetings, and staff collaboration offer additional opportunities for professional growth. Teachers observe other professionals, engage in peer coaching, and work with mentors and grade-level or departmental colleagues.
