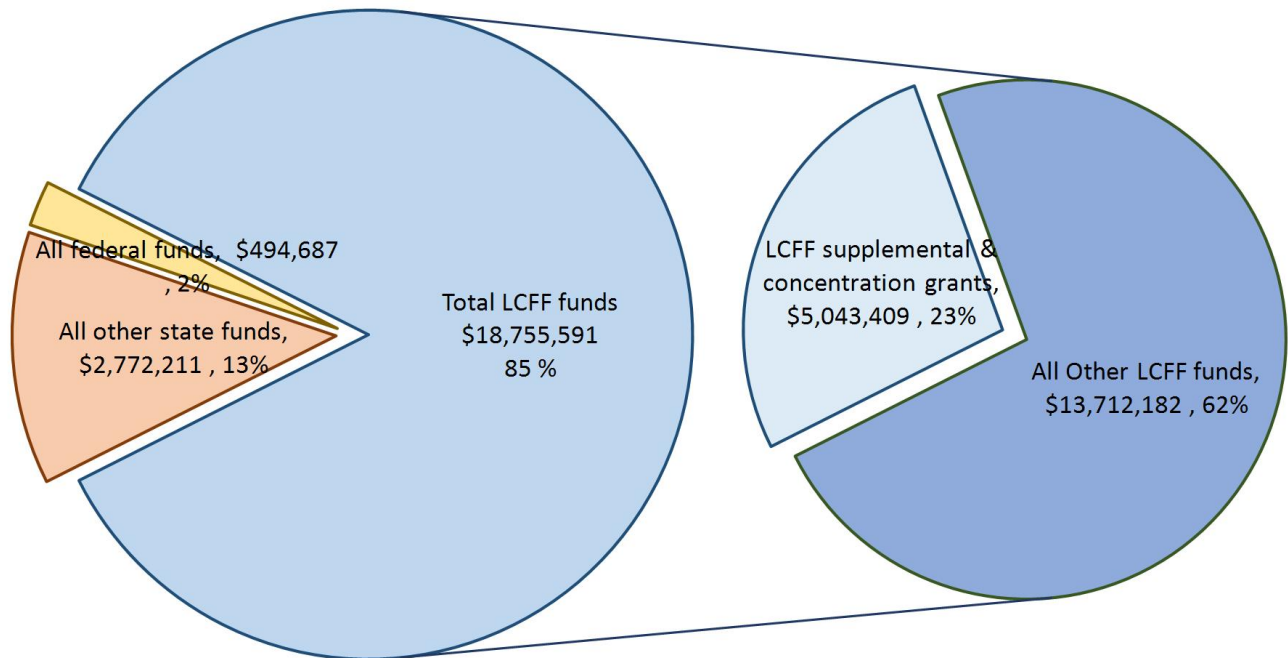

Projected Revenue by Fund Source

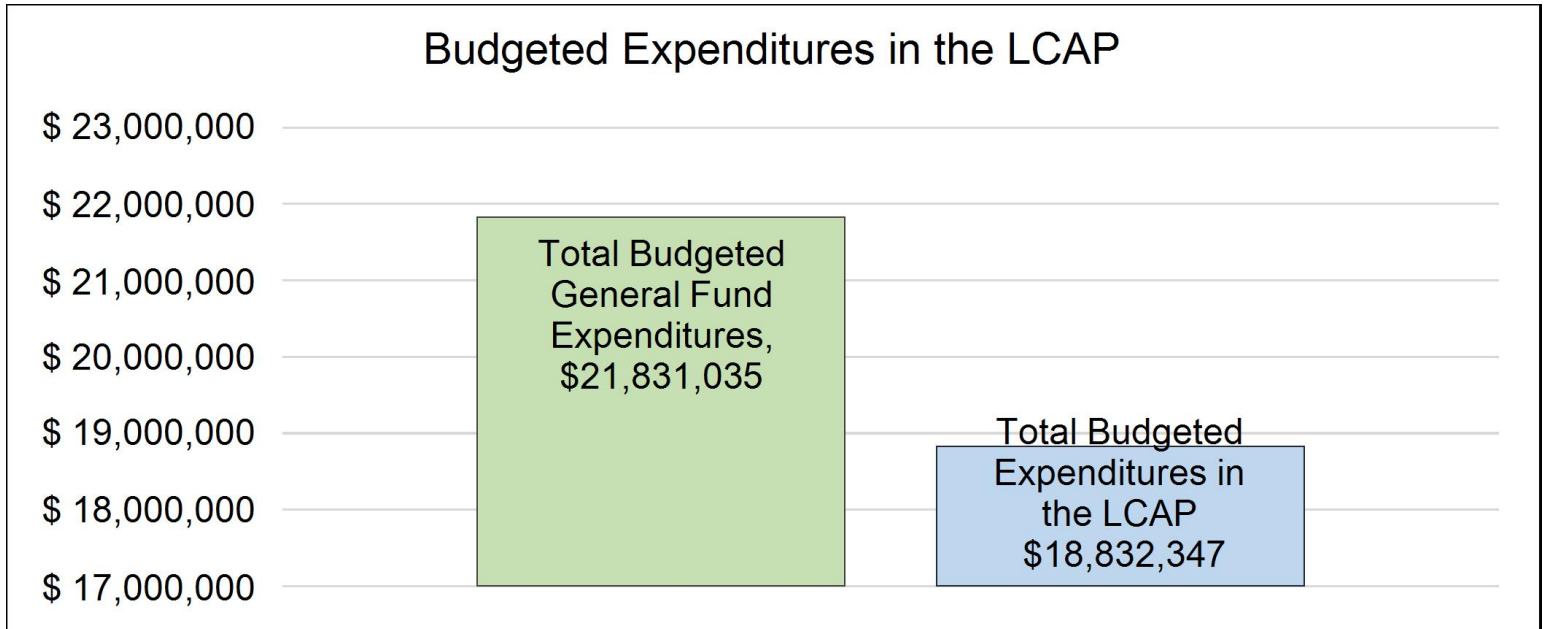


This chart shows the total general purpose revenue Antelope Valley Learning Academy expects to receive in the coming year from all sources.

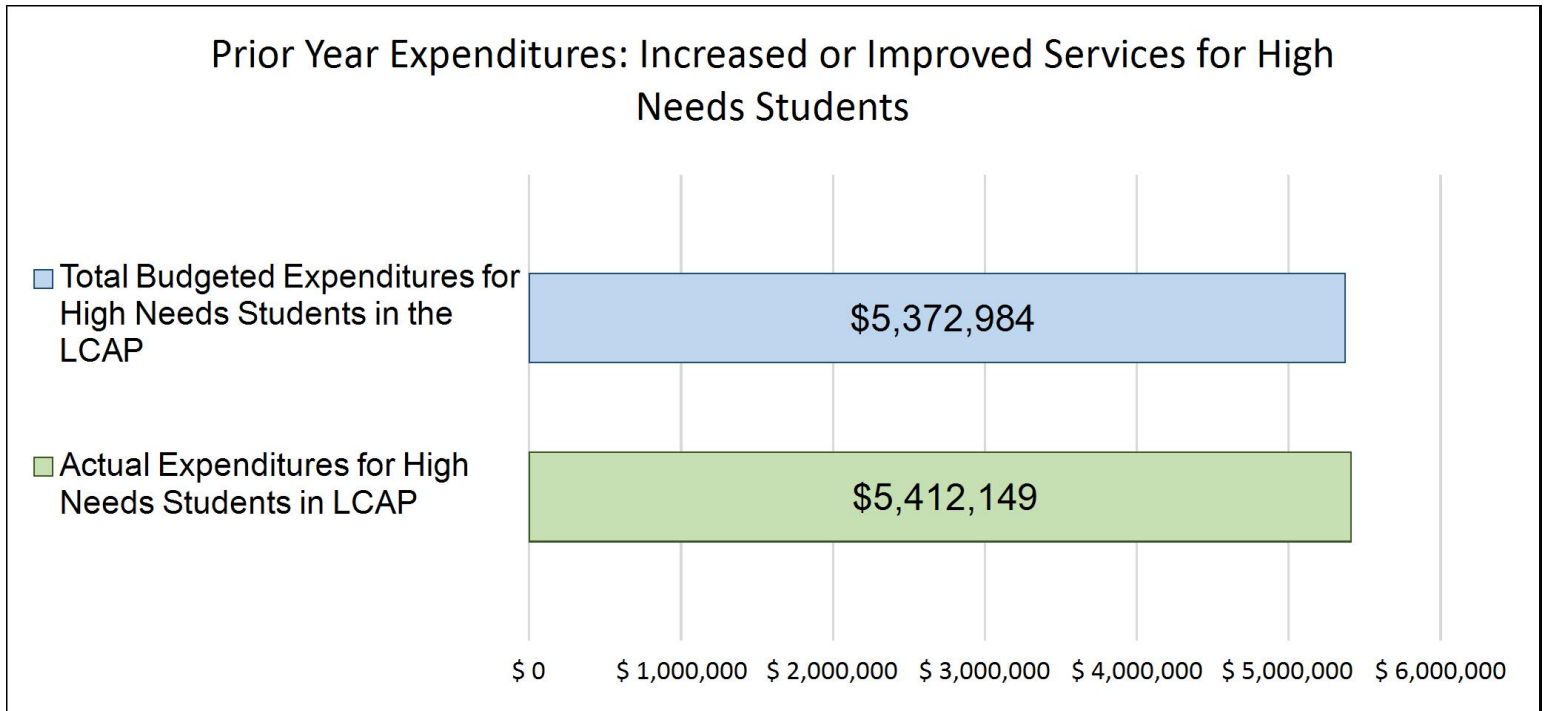

California’s 2021–22 Budget Act, the federal American Rescue Plan Act of 2021, and other state and federal relief acts have provided local educational agencies (LEAs) with a significant increase in funding to support students, teachers, staff, and their communities in recovering from the COVID-19 pandemic and to address the impacts of distance learning on students. The following is a one-time mid-year report to the local governing board or body and educational partners related to engagement on, and implementation of, these Acts.

Antelope Valley Learning Academy (AVLA) was able to engage its educational partners using Microsoft Teams, GoogleMeets, and Zoom. Parents were notified, in English and Spanish, of the meeting through our L4L Connect, email and texts. The meeting was held on November 17, 2021. During the meeting, parents were informed of the additional 15% increase in funding, resulting in \$642,268 more to be directed at supporting their students. It was explained that, because this funding was not initially included in the 2020-2021 LCAP, it was important to receive their consultation into how the funds could be spent. Their input was elicited during the meeting. Teachers and staff were also provided the opportunity to provide consultation on November 15, 2021.

The additional funds from the ELO grants were shared with our educational in June 2021; EEBG funding was shared in December 2021, and A-G funding was shared in January 2022. Some of the details shared with them at the meeting were the purpose of the grant, type of funding, aligning spending to site strategic plans, and innovative ways to increase student/parent engagement.

AVLA is a charter school serving an unduplicated population over 55%. We plan to use the additional 15% in supplemental and concentration funding to support our LCAP, which can be found at <https://avlearning.org/wp-content/uploads/2021/10/Antelope-Valley-Learning-Academy-Local-Control-and-Accountability-Plan-2021-2022-10.11.2021.pdf>.

The additional funds will be used to specifically add more teachers and staff identified in our LCAP:

- LCAP Goal 1, Action 2 will be increased by \$225,000 to add two more FTE positions.
- LCAP Goal 1, Action 3 will be increased by \$45,000 to add a Tutor.
- LCAP Goal 2 Action 1 will increase by \$105,000 to add one FTE to support college/career efforts.
- LCAP Goal 3 Action 1 will increase by \$175,000 to retain supports for student retention efforts.
- LCAP Goal 3 Action 2 will increase by \$100,000 to add an additional counselor.

We currently have positions open for the following: LCAP Goal 1 Action 2—One content area teacher and one tutor.

These increases to these actions equal the amount the additional funds in supplemental and concentration allotment. These funds are principally directed at meeting the identified needs of our low-income, English learner, and foster youth students.

AVLA is actively implementing its Local Control and Accountability Plan. The Mid-Year Report shows specifically how funds are being expended for each goal and every action in the LCAP.

This year, we have hired an additional counselor—LCAP Goal 3 Action 2, a State/Fed Coordinator to manage intervention programs—LCAP 1 Action 2, and a College/Career Coordinator to align CCI indicators to the strategic plan—LCAP Goal 2 Action 1.

We currently have positions open for the following: LCAP Goal 1 Action 2—One content area teacher and one tutor.

We implemented the Safe Return to School Plan July 2021. Various funding streams are being allocated to execute and maintain the plan, including monthly safety walks, professional development, community workshops, and additional intervention programs. The plan is reviewed and updated as necessary to meet state and local requirements.

Our Educator Effectiveness Block Grant, and the Extended Learning Opportunities grant are aligned to our Local Control and Accountability Plan. The EEBG is linked with LCAP Goal 2 – Action 2 regarding professional development. For example, we have secured both internal and external professional learning engagements to drive progress across all four LCAP goals. Teachers, tutors, instructional coaches, counselors, and administrators each have professional learning designed to build expertise and capacity. The ELO is supporting LCAP Goal 1 – Actions 2/3 with extended learning opportunities, so that all students can reach their goal of earning a diploma and create a post-secondary plan.

We did not receive ESSR III funds.

Plan Summary [2022-23]

General Information

A description of the LEA, its schools, and its students in grades transitional kindergarten–12, as applicable to the LEA.

Antelope Valley Learning Academy is a Dashboard Alternative School Status (DASS) school, with an independent study and Home Study program. Current enrollment is 1539, and serving 10% English Learners, 85% low income, 1.5% foster youth, 3.0% homeless, and 18.1% special education students. AVLA is a charter school that serves a diverse student community with the mission of engaging students in learning, who are no longer enrolled in a traditional classroom program, or who prefer a personalized learning education in an alternative setting. Our goal is to successfully prepare students for work or college-readiness through our integrated and personalized program of job readiness coursework and standards-based curriculum, equipping them with the educational skills necessary for the 21st century.

Some students need the flexibility of an independent study model to meet family obligations, such as work or child care needs. Many students reflect a diverse community with often low-income and English as a second language being a barrier to academic success. Some students may have been unsuccessful in the traditional school setting and simply seek an alternative choice in curriculum programs. The school offers alternative choices through site-based learning, independent study, home study, and distance learning to enable students to acquire the knowledge necessary to make a difference in their lives. The independent study program is a year-round credit recovery program, with 13 Learning Periods (LP) as the method of structuring the academic year.

The AVLA Home Study Program is geared for younger (K-8) students, or high school aged students (9th-12th), who are interested in an alternative to the traditional classroom. Parents are highly involved in their student’s education and are, in fact, the student’s primary direct instructor, with support and guidance from the credentialed teachers on staff. Home Study students are typically not considered “at promise”.

The Home Study model mimics the traditional school environment in many ways, with the most significant difference being the delivery of the educational program – at home by the parents who adhere to a set schedule that benefits each family's lifestyle. Parents work closely with their student's Supervising Teacher to establish Academic Plans and support student learning.

AVLA provides a diverse, student-centered learning environment in which all students are held to high academic and behavioral standards. AVLA also emphasizes increased parental involvement, more one-on-one teacher and student interaction, student-driven participation in the learning process, technology access, varied learning environments, and choices in curriculum programs.

AVLA's personalized learning model is tailored to the needs and interests of each individual student. It is a combination of independent study, home schooling and resource center based small group instruction (SGI) and Career Technical Education (CTE) classes. Personalized learning is dedicated to developing personalized learning programs for each student. Its intent is to engage each student in the learning process in the most productive and meaningful way to optimize each student's learning potential and success. It allows the school to combine multiple assessment levels of student academic achievement through the regular recording of detailed learning records, compiling student work samples, and conducting annual state-mandated testing programs. The school offers this personalized learning option for students with the ultimate objective of enabling students to become self-motivated, competent and lifelong learners.

The 2021-22 School Year was the first year AVLA accepted Title 1 funds. In 2022-23 AVLA will move to a Schoolwide Title 1 Program and the Title 1 funds will be reflected in this LCAP as a means of meeting the School Plan for Student Achievement requirements. The Title 1 funds will be used to supplement the strategic plan represented in this plan to help our at-risk students meet state standards and graduate.

Reflections: Successes

A description of successes and/or progress based on a review of the California School Dashboard (Dashboard) and local data.

We believe that the reengagement strategies that we implemented, to help students and families during the crisis, also increased the student's average attendance rate by +2.97 points, up to 82.7% through the end of 2021-22 Fall Semester. Our teachers and retention support staff worked to address the serious concerns we had for students dropping out. Building relationships and staying connected to students decreased the dropout rate by 71.4%, to only 2.4%. Another important measure for us is our Success Rate, which is the percentage of students who graduate along with the percentage that are retained or return to their local school district. Our Foster Youth and Student with Disabilities group's success rate was 11.83 percentage points and 1.83 percentage points higher, respectively, than our "All" group. Our dedicated staff and students successfully pulled together during the pandemic to remain engaged in the school program.

- AVLA's Foster Youth graduation rate was +2.62 percentage points above the "All" Group graduation rate.
- AVLA's Low Income student group was 0.14 percentage points above the "All" Group CAST score.

- AVLA's Foster Youth was 8.6% higher in the NWEA Math Quantile score and 10.6% higher in the NWEA Reading Lexile score than the "All" Group.

We plan to increase our success by sustaining our system of continual improvement for student groups. We used student outcomes data from the latest DataQuest, CA Dashboard, CALPADs reports and local LCAP data tracking have clearly demonstrated that there are three main areas that must be addressed as goals and actions for the new 2022-2023 LCAP. One critical focus of our program is to improve the performance of our disengaged students. We identify, early on, which students are not completing their school work and then assign them tutors to ensure that they helped support student learning. AVLA is continuously developing strategies to increase the collaborative teamwork between our teachers, tutors, and counselors.

We also plan to sustain our success by implementing our school strategies and learning program to fidelity. The goals and actions articulated in our LCAP support our individualized learning model and adequate funding is provided to ensure that effective strategic supports such as tutors, student retention services and trauma informed trained teachers continue. We monitor the progress of our students through multiple measures around engagement and academic performance. LCAP data and other local data are discussed quarterly and often shared with our educational partners, including the school board.

Our school survey data shows that 100% of our students felt safe at school this year, which is a +16% increase from last year's survey result. Additionally, 94% felt connected to the school this year, which is a 55% increase from last school year. This is very important to us, because students' sense of safety impacts their learning and social-emotional well-being. 93% of parents feel that the school is making progress in creating welcoming environments for all families. Teachers reported that 99% feel connected to the school which is a 4% increase from last school year.

Reflections: Identified Need

A description of any areas that need significant improvement based on a review of Dashboard and local data, including any areas of low performance and significant performance gaps among student groups on Dashboard indicators, and any steps taken to address those areas.

The CA Dashboard for 2020-21 and 2021-22 was suspended as a result of AB 98 and AB 130. However, results from 2019 and local metrics provided us a three year data set, which we used to inform our student group analysis. The first area of concern is that our CAASPP results show that English Learners, Foster Youth, Low-Income and Students with Disabilities are scoring below the "All" Group in English Language Arts and mathematics. We saw similar achievement gaps over the past three years and during the pandemic, in key areas, such as ELA, mathematics, and credit completion. Through the 2021 Fall Semester, the credit completion of our English Learner students (3.4%), Foster Youth (46.1%), Low Income (6.4%), and Students with Disabilities (31.2%) were below the "All" Group credit completion of 3.21.

The 2021 CAASPP results for our English Learners was 3.69 percentage points below the All student group in mathematics and 28.27 percentage points below in ELA. Our Low Income students were 2.46 percentage points below in ELA and 1.94 percentage points in mathematics. Our Foster Youth students were 6.62 percentage points below the All Group in mathematics. Students with Disabilities were 3.97 percentage points below the All Group in mathematics and 23.96 points below in ELA. We plan to share student performance data with

our educational partners and use their feedback along with our analysis, to help develop LCAP goals with actions directed at these areas of identified need.

The next area of concern is that the reclassification rate is currently at 3%, which is below the state average of 8.6%. We plan to share this performance outcome with our educational partners and discuss how we might provide targeted assistance to our English Language learners. We work with our English Learner Advisory Committee and elicit their insight. We will determine the specific actions that address the specific requirements for reclassification like course completion and grades in ELD, NWEA scores, and ELPAC scores that might improve performance on the ELPAC. With the success we have seen in our tutoring program, we know they can help make a difference in the academic lives of our English Learners.

Closing the gaps in our graduation rate have been improving, although we are not yet satisfied. The All student group graduated at 77.38%, with Foster Youth, Low Income and Students with Disabilities groups graduating at a rate below the "All" Group. However, our English Learners graduated at 4% higher--82%. We plan to share this performance data with our educational partners and determine specific actions that will have a positive impact for our students.

Another area of concern is NWEA reading and mathematics scores decreased from last year to this year. The scores for our English Learners were 121 points lower in mathematics and 205 points lower in reading than the "All" Group. We recognize how important it is for our EL's to experience targeted support and interventions as they progress in their educational program. The scores for our Low Income students were 2 points lower in mathematics and 10 points lower in Reading. However, our Students with Disabilities scored 208 points lower in mathematics and 183 points lower in reading. We plan to engage families and students in their individualized academic learning plan and support systems like tutoring and counseling, so that their educational performance is maximized at our school. Yet, Foster Youth outscored all subgroups with 64 points higher in mathematics and 101 higher reading.

Our school survey data shows that 99% of our students felt a sense of belonging to the school this year. This is an important metric for us and we want to maintain this high rate. Face to face interaction with a caring adult as well as student participation in school events and activities will help students feel a greater sense of being a part of the school. It is very important to us to ensure that we are doing everything possible to provide students with time and attention to support them during their time with us. 79% of our parents stated that the school encourages their participation and input in activities, events, and parent workshops/meetings. It is very important that the school continues to create good relationships with parents as well as communicating the importance of their feedback and input in school decisions and their attendance at different parent meetings and school activities. School staff stated that 98% feel that teachers and parents think of each other as partners in educating students. We expect this metric to be higher as we continue to improve on our school connectedness and school/parent partnerships. School staff also stated that 99% feel that their voice is welcomed and heard at the school. AVLA will continue to improve communication between administration and staff in collective decision making as well as communicating the importance of their feedback and input in school decisions.

Due to the nature of our credit recovery, independent study, Dashboard Alternative School Status program, certain data points are not included in the LCAP. Students do not take Advance Placement, or pass EAP in an amount greater than 11, and the CDE prohibits any potentially identifying student data. Chronic absenteeism is also not a match for our program, because the calculation is for seat-based

programs, and not short term independent study programs that have high mobility. Furthermore, our dropout rate is calculated as our non-completer rate, which includes any student who does not report to us that they have continued with another program, in order to complete their education.

LCAP Highlights

The Local Control Accountability Plan (LCAP) provides funds for helping high needs students with social-emotional support, academic interventions, counseling and student engagement activities. Students have access to a robust tutoring program that supports their learning. Targeted academic interventions help close skill and knowledge gaps ensuring that students become competent graduates.

The following LCAP Goals support our low income, English Language learners and foster youth:

Goal #1: Increase Academic Progress

This year we received Title 1 funds and we are using the LCAP as our School Plan for Student Achievement (SPSA). We are adhering to federal guidelines for involving our educational partners in the needs assessment, parent compact, parent/family engagement policy and input into the direction of the use of federal funds. We held our Title 1 Meetings on 11/17/2021 and shared student performance gaps and discussed how the federal funds could help by offering tutoring focused on literacy support. Throughout the year, we met to discuss student needs and how the funds could be appropriately directed to help improve student performance. Their input was incorporated into this LCAP.

AVLA used a variety of methods to solicit input from all the educational partners. These groups included parents, teaching staff, support staff, administrators, students, and school counselors. Throughout the year, we held several different types of meetings to engage our educational partners: e.g. ELAC/PAC meetings, Parent-Teacher Conferences, Staff meetings, department meetings, surveys, PD breakout sessions, etc. In addition, we shared progress with LCAP goals, discuss actions that were implemented to achieve the goals, and share evidence that showed progress toward meeting positive outcome targets. More importantly, we distributed surveys to solicit feedback to determine needs and/or barriers to success.

Administrators reviewed data aligned with the metrics to determine if progress was being made in achieving desired outcomes. Various meetings were scheduled as data became available locally and through the state (e.g. Dashboard data). Data analysis included a broad overview of reviewing aggregate data to determine areas of progress and/or concern.

AVLA has no Certificated or Classified bargaining units.

In May, a draft of the LCAP was posted onto the school website for two weeks and made available for public comment. The public was provided the opportunity to call or email the principal and provide their input during this time. No input was received.

The Public Hearing was held on June 1, 2022, and our school approved our Local Control and Accountability Plan. Copies of the LCAP were available online, prior to the meeting, along with the board agenda. Educational partners were given the opportunity to provide comment to the charter school board, prior to its approval. The Local Indicators were also presented at the same board meeting that the LCAP was approved. The Board adopted the budget at the same meeting of the LCAP Adoption.

- All goals and actions will be continued and monitored. Community partners were supportive of maintaining the broad goals that captured specific actions intended to provide services to all students and actions intended to provide services to English Learners, foster youth, low-income students, and students with exceptional needs.
- There will be a continued focus on Goal #3: Increase Student Retention, previous Goal #1
- We will allocate more resources to address SEL components to gain college and career readiness.

We will continue to collaborate with community partners throughout the school year to explore and monitor the progress of implemented actions.

- -Parents and PAC/ELAC believe more parents may be more apt to be involved if meetings were held later (after work hours).
- -Parents and PAC/ELAC do not feel they have been aware of programs/services for the development of underrepresented groups in the school community.

We will continue to collaborate with educational partners throughout the school year to explore and monitor the progress of implemented actions.

A description of the aspects of the LCAP that were influenced by specific input from educational partners.

As a result of community partner input, Antelope Valley Learning Academy will implement goals that align to our mission/vision and community needs. Specifically, Goal 2 (Students will gain skills for college or career-readiness) and Goal 4 (Educational Partner Engagement) directly correlate to the needs and concerns raised by educational partners. Students, parents, and staff all communicated the importance of students gaining and demonstrating college and/or career skills as evidenced by engagement in college-level courses, tutoring access, and the ability to inform site decisions.

In addition, our students, parents, and staff all communicate the need to eliminate barriers to students' success in our program. Specifically, they asked for increased resources to meet EL needs, additional 1:1 extended academic support, additional support to increase technology proficiency, and convenient meeting hours/locations.

1	<p>Increase Academic Progress:</p> <p>This is a focus goal for increasing academic progress for all students, especially our English Language learners, low-income and foster youth, who struggled during the previous year. In the next three years, we will have mitigated the negative impact learning loss had on our students, and we will see improvement in our NWEA, EL reclassification, credit completion and graduation rates.</p>

An explanation of why the LEA has developed this goal.

As a result of our analysis on key state and local data, we determined the need for a focus goal on academic performance for all our English Learners, low income, and foster youth students. This new goal specifically addresses low key metrics such as the English Learner reclassification rate, credit completion, and graduation for our student groups. We looked at our student group data, which reveal performance gaps between the "All" Student Group, and the English Learners, low income, and foster youth students. Our students also take the NWEA MAP assessment, and we measure academic growth from year to year in this way. This year, performance gaps among student groups were also revealed, using that assessment. We understand the gaps that need to be closed for our students, and this focus goal was carefully designed to support their academic needs with targeted interventions and tutoring.

We sought the consultation of our educational partners, and involved them in the LCAP process, which we believe promotes positive engagement, buy-in and trust. We know that additional tutoring, interventions, and counseling support will help address the learning loss over the next few years.

Our English learner students show the most opportunity for continued academic improvement based on the most current state and local ELA and Math data as reflected in the metric tables. Based on a local needs assessment we have found that our English learner students need additional support and scaffolds to be successful. We will address this need by providing an EL Paraprofessional or other trained bilingual support personnel. This includes, but is not limited to EL tutors, ELD Leads, support staff, ELD Small Group Instruction, and supplementary materials for the ELD program as needed. Students will receive individualized support based on their specific English proficient level. We use an Individualized English Language Development Plan (IELDP) in collaboration with students and families. Support staff will provide specific language instruction through vocabulary and language development to support literacy skills and language acquisition. We anticipate the student performance on CAASPP Math and ELA, as well as on the English Learner annual growth assessment will reveal improved performance for these students. This action is designed to meet the needs most associated with English learner students. Using real time tracking, student language proficiency and academic progress will be monitored, and we expect that their ELPAC scores, as well as the reclassification rate, to increase as a result of the personalized academic support they will receive from qualified personnel.</p>	\$178,248.00	Yes

Goal Analysis [2021-22]

An analysis of how this goal was carried out in the previous year.

A description of any substantive differences in planned actions and actual implementation of these actions.

Overall, we were able to implement the main components of the actions in the goal. Essential academic interventions were implemented for our students with the highest needs. They were supported by the intervention programs and tutoring. Tutors provided on-site and virtual support to our students in order to improve their credit completion efforts. Credit completion increased by 70% this year.

During the pandemic, we were challenged at times, with not being able to quickly fill staff vacancies and sustain a 100% highly qualified staff. Our leadership and staff adapted to mitigate the potential impact on our students. Currently there are 3 staff vacancies, and we have 91% highly qualified teachers serving our students.

Although we implemented most of Action 5, Student Activities That Increase Learning Efforts, were not able to provide as many of the field trips this year, as we have in the past; however, students did attend several experiential learning opportunities to D.C, Las Vegas, Hawaii, and Catalina Island.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

There were material differences that occurred as a result of not being able to implement field trips and English learner supports. However, this did not impact the Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services, because other strategies, such as tutoring and counseling, within the action were implemented, and which were principally directed towards our English Language learners, low income and foster youth students.

An explanation of how effective the specific actions were in making progress toward the goal.

Overall, the combined actions of this goal have increased the academic progress of our students as measured by key metrics such as the graduation rate, credit completion rate, and NWEA. This is the results of a comprehensive and strategic approach to helping students complete their coursework and earn credits towards graduation. Our intervention programs and tutors were able to help us realize a 70% increase in our credit completion rate. We are constantly focused on helping to improve the literacy and math skills of our skills as demonstrated by a 30% increase in NWEA scores. The improvement shown in credit completion and NWEA growth demonstrates that we are making progress in this goal.

A description of any changes made to the planned goal, metrics, desired outcomes, or actions for the coming year that resulted from reflections on prior practice.

There were a couple of changes made to the metrics reported in this goal. First, we were reporting RIT scores for NWEA Reading and math results, and now we are reporting Lexile and Quantile scores, because that aligns with how scores are reported at a national level. We did

this in order to be more comparable with other schools using Lexile reading scores and Quantile math scores. Secondly, there was no baseline calculation for the English Learner Performance Indicator, so we reported ELPAC Levels 1-4, in order to show that we are examining the data that is available for our English learners. This year AVLA is using the LCAP to meet the federal requirements for the SPSA. An additional action was included to describe the Title 1 program and uses of those funds under this goal.

Goal Analysis [2021-22]

An analysis of how this goal was carried out in the previous year.

A description of any substantive differences in planned actions and actual implementation of these actions.

We were able to implement the actions in our career and college-readiness, through standards-based coursework, and supplemental learning activities for our English Learners, low income and foster youth students. Technology upgrades and support for students' connectivity and programs continued to be a priority. We were able to build capacity of our teams through both coaching and conferences. Staff participated in conferences related to Illuminate, PLC, EL, SEL, SPED, and Foster/Homeless supports.

We were challenged, during the pandemic, with not being able to enroll more students in CTE courses, due to CDPH guidance. Currently, there are 268 students in a CTE pathway and 52 students enrolled in dual enrollment courses. We have 212 students in professional skills courses this year. Overall, students had access to the college and career activities at our school and those who could take advantage of them did so.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

There were material differences that occurred as a result of not being able to implement support for standards-based curriculum in all areas. However, this did not impact the Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services, because other strategies; such as technology for students and professional development, within the action were implemented, and which were principally directed towards our English Language learners, low income and foster youth students. We exceeded our budgeted expenditures as shown in the 2021-2022 Contributing Actions Annual Update table for estimated actual expenditures due to increased expenditures to implement college-career opportunities.

An explanation of how effective the specific actions were in making progress toward the goal.

We effectively implemented our College and Career-Readiness goal, as measured by key metrics, such as participation in CTE and Professional Skills courses, a standards-based curriculum, and the California Assessment for Student Performance and Progress. Our English Learners, low-income, and foster youth students were able to engage in activities that focused on career-readiness and/or college readiness. Professional skills courses had an enrollment of 212 this year. 100% of our students had access to a broad range of courses. We were able to implement our college and career-ready, standards-based instructional program this year. Additionally, we ensured that students had access to technology and a high level of connectivity in order to support their learning efforts. In addition, 52 students engaged in and passed dual enrollment courses offered by our post-secondary partners.

A description of any changes made to the planned goal, metrics, desired outcomes, or actions for the coming year that resulted from reflections on prior practice.

New this year is the required metric for measuring the percentage of seniors completing the A-G courses and a CTE pathway. This is a challenging combination of specific course completion for very high performing students. Last year only 1.2% of our seniors were able to be counted in this metric. We are using the most current data from the CDE's DataQuest.

Goal Analysis [2021-22]

An analysis of how this goal was carried out in the previous year.

A description of any substantive differences in planned actions and actual implementation of these actions.

Our goal for Increasing Student Retention was successfully implemented this year. Our English learners, low-income and foster youth were serviced by our student retention personnel which helped us increase our Success Rate by +1.1 percentage points. Our attendance rate is currently at 87.5%, which is higher than last year. This local data is currently not disaggregated, and we are hoping to improve our capacity to report by subgroup.

The pandemic forced us to redouble our efforts to re-engage students, which included directing funds towards feeding and transporting students to school if necessary. Although we expended some funds for nutrition, we will adjust the amount of funding necessary to meet our students' nutritional and transportation needs. Our low income students were able to access food and transportation as needed.

We implemented most of Action 3.2, at a greater degree than in the past, due to special circumstances created by the pandemic. We adapted by providing other engaging and meaningful student activities to support their needs, such as support groups, virtual hangouts, and extended learning hours for tutoring. These activities helped student social-emotional needs.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

There were material differences that occurred as a result of not being able to implement transportation and meals as anticipated. Also, some social-emotional support was not fully implemented and were not able to adequately backfill positions. However, this did not impact the Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services, because other strategies, such as hiring a School Social Worker, within the action were implemented, and which were principally directed towards our English Language learners, low income and foster youth students.

An explanation of how effective the specific actions were in making progress toward the goal.

Overall, we have increased the retention of our students as measured by key metrics, such as the success rate, retention rate and low drop-out rate. As shown above, in the Measuring and Reporting Results chart, the Success rate increased to be 94.7% in 2022. This is the result of a comprehensive and strategic approach to helping students remain engaged in their education and help them overcome barriers to learning. Our efforts to re-engage students resulted in an increase in our Retention rate to 93% this year. The dropout rate this year is 4.6%, which is a significant improvement from last year. Additionally, the attendance rate is above what it was last year, and is now at 87.5%. These metrics show that we have improved retention and that the actions are effective in this goal.

AVLA did not spend the nutrition or transportation funds budgeted due to the pandemic. Funds for nutrition and transportation will be adjusted and reduced in the coming year. An analysis of how this goal was carried out in the previous year.

A description of any substantive differences in planned actions and actual implementation of these actions.

We were able to implement the actions in Goal #4, Increase Educational Partner Engagement. This was a challenge for us last year, but as a result of adapting additional methods of connecting and engaging our partners, we were able to sustain and improve on some of our actions. Parent conferences, orientations and school events were in-person this year and we continued to utilize the virtual meetings platforms to engage parents that way if they desired that option. PAC/ELAC meetings were also held this year and so far we have had 29 participants.

We are continually trying to improve how we can engage the most amount of parents and give them input into the school. We increased our participation on our school survey, which helped provide insight into our LCAP goals and other school processes. Of the parents responding to the survey, 79% feel encouraged to participate.

We implemented most of Action 2.1, Community/Parent Liaison, and we were not able to provide as many of the activities, as we have in the past. We adapted by providing other engaging and meaningful engagement activities such as Open House, Back-to-School, Truck-or-Treat, and Awards Night. This is an important goal for us and our educational partners would like to keep this goal moving forward.

There were material differences that occurred as a result of not being able to implement translation services and educational partner/community events. However, this did not impact the Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services, because other strategies, such as participating in community events, within the action were implemented, and which were principally directed towards our English Language learners, low income and foster youth students.

An explanation of how effective the specific actions were in making progress toward the goal.

Overall, we were successful with this goal, as measure by the school survey and participation results. We saw an increase in parents feeling encouraged to participate rise to 79% this year. We believe that our positive engagement efforts resulted in 100% of the students reporting that they feel safe this year and 99% of the teachers reporting that they feel connected. Participation in conferences and PAC/ELAC meetings has held steady or started to improve this year.

AVLA did not spend the school activities, translation, or materials for educational partner event funds due to the pandemic. Introduction and Instructions

The Local Control Funding Formula (LCFF) requires local educational agencies (LEAs) to engage their local educational partners in an annual planning process to evaluate their progress within eight state priority areas encompassing all statutory metrics (COEs have 10 state priorities). LEAs document the results of this planning process in the LCAP using the template adopted by the State Board of Education.

The LCAP development process serves three distinct, but related functions:

- **Comprehensive Strategic Planning:** The process of developing and annually updating the LCAP supports comprehensive strategic planning (California *Education Code* [EC] Section 52064[e][1]). Strategic planning that is comprehensive connects budgetary decisions to teaching and learning performance data. LEAs should continually evaluate the hard choices they make about the use of limited resources to meet student and community needs to ensure opportunities and outcomes are improved for all students.
- **Meaningful Engagement of Educational Partners:** The LCAP development process should result in an LCAP that reflects decisions made through meaningful engagement (EC Section 52064[e][1]). Local educational partners possess valuable perspectives and insights about an LEA's programs and services. If a county superintendent of schools has jurisdiction over a single school district, the county board of education and the governing board of the school district may adopt and file for review and approval a single LCAP consistent with the requirements in *EC* sections 52060, 52062, 52066, 52068, and 52070. The LCAP must clearly articulate to which entity’s budget (school district or county superintendent of schools) all budgeted and actual expenditures are aligned.

The revised LCAP template for the 2021–22, 2022–23, and 2023–24 school years reflects statutory changes made through Assembly Bill 1840 (Committee on Budget), Chapter 243, Statutes of 2018. These statutory changes enhance transparency regarding expenditures on actions included in the LCAP, including actions that contribute to meeting the requirement to increase or improve services for foster youth, English learners, and low-income students, and to streamline the information presented within the LCAP to make adopted LCAPs more accessible for educational partners and the public.

After assessing the needs, conditions, and circumstances of our low-income students, we learned that the attendance rate of our low-income students is 7 percent lower than the attendance rate for all students. (Needs, Conditions, Circumstances [Principally Directed])

In order to address this condition of our low-income students, we will develop and implement a new attendance program that is designed to address some of the major causes of absenteeism, including lack of reliable transportation and food, as well as a school climate that does not emphasize the importance of attendance. Goal N, Actions X, Y, and Z provide additional transportation and nutritional resources as well as a districtwide educational campaign on the benefits of high attendance rates. (Contributing Action[s])

These actions are being provided on an LEA-wide basis and we expect/hope that all students with less than a 100 percent attendance rate will benefit. However, because of the significantly lower attendance rate of low-income students, and because the actions meet needs most associated with the chronic stresses and experiences of a socio-economically disadvantaged status, we expect that the attendance rate for our low-income students will increase significantly more than the average attendance rate of all other students. (Measurable Outcomes [Effective In])

COEs and Charter Schools: Describe how actions included as contributing to meeting the increased or improved services requirement on an LEA-wide basis are principally directed to and effective in meeting its goals for unduplicated pupils in the state and any local priorities as described above.
