# **BACKGROUND**

The Palmdale School District Personnel Commission consists of three members. One is nominated by the classified employees, one by the Board of Trustees, and one is selected by the appointed members.

The Joint appointment will be available when the current Joint Commissioner's three-year term expires. A new appointment is expected at the December 2015 meeting. The three-year term for the Joint appointment is from December 1, 2015 to November 30, 2018.

## STATUS

At the meeting of September 21, 2015, candidates invited for consideration of the Joint Personnel Commissioner appointment will be interviewed in open session. Candidates invited to interview submitted an application, passed Education Code requirements, and were rated/ranked by Subject Matter Experts (SME) prior to presenting before the District-appointed Commissioner and the CSEA-appointed Commissioner.

## <u>RECOMMENDATION</u>

After conducting interviews in open session, the Commissioners are expected to approve a selection. Public input regarding the selected candidate will be afforded at an upcoming regular (or re-scheduled regular) Personnel Commission meeting.
