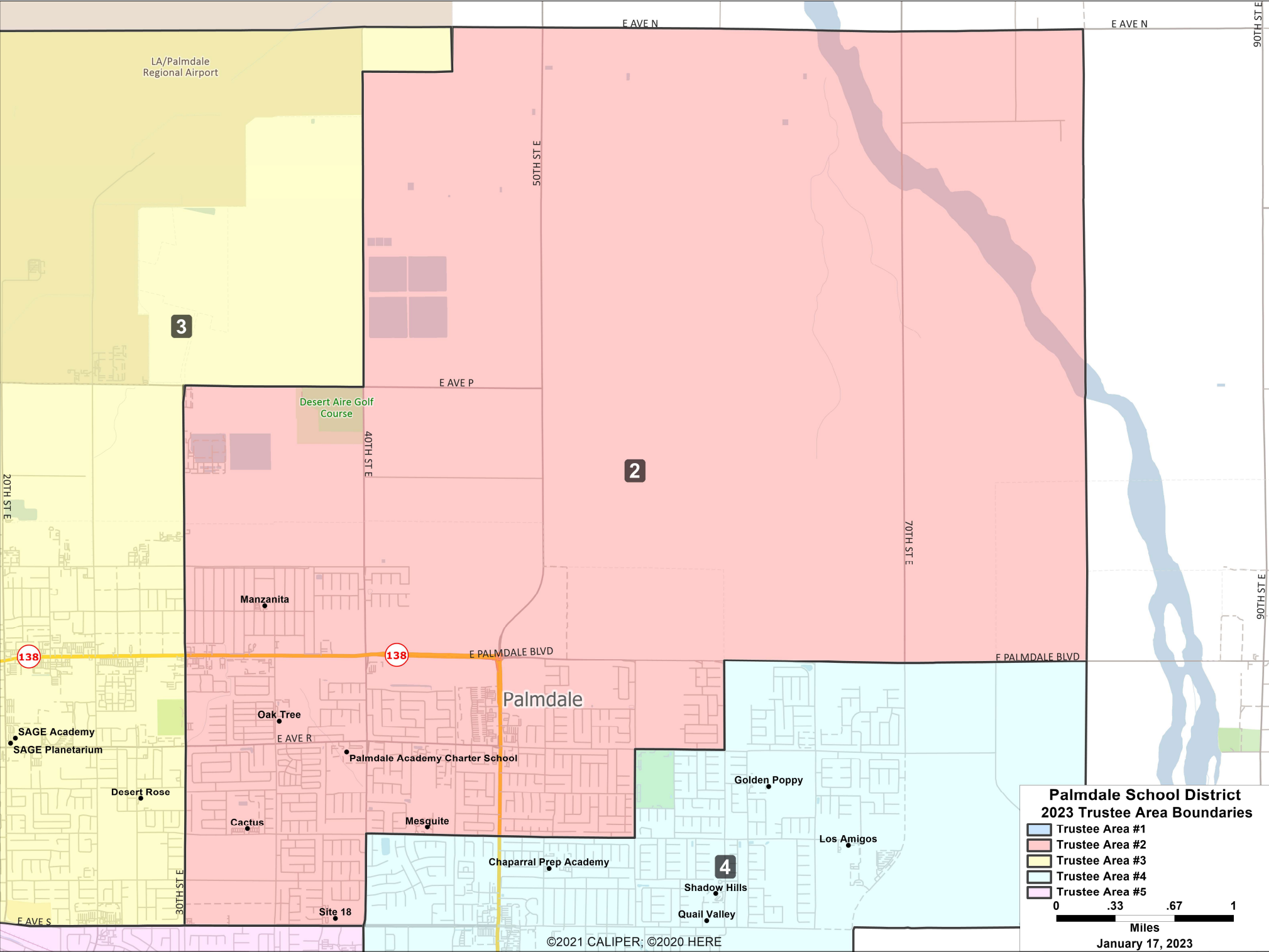
2023 Trustee Area Boundaries FINAL MAP

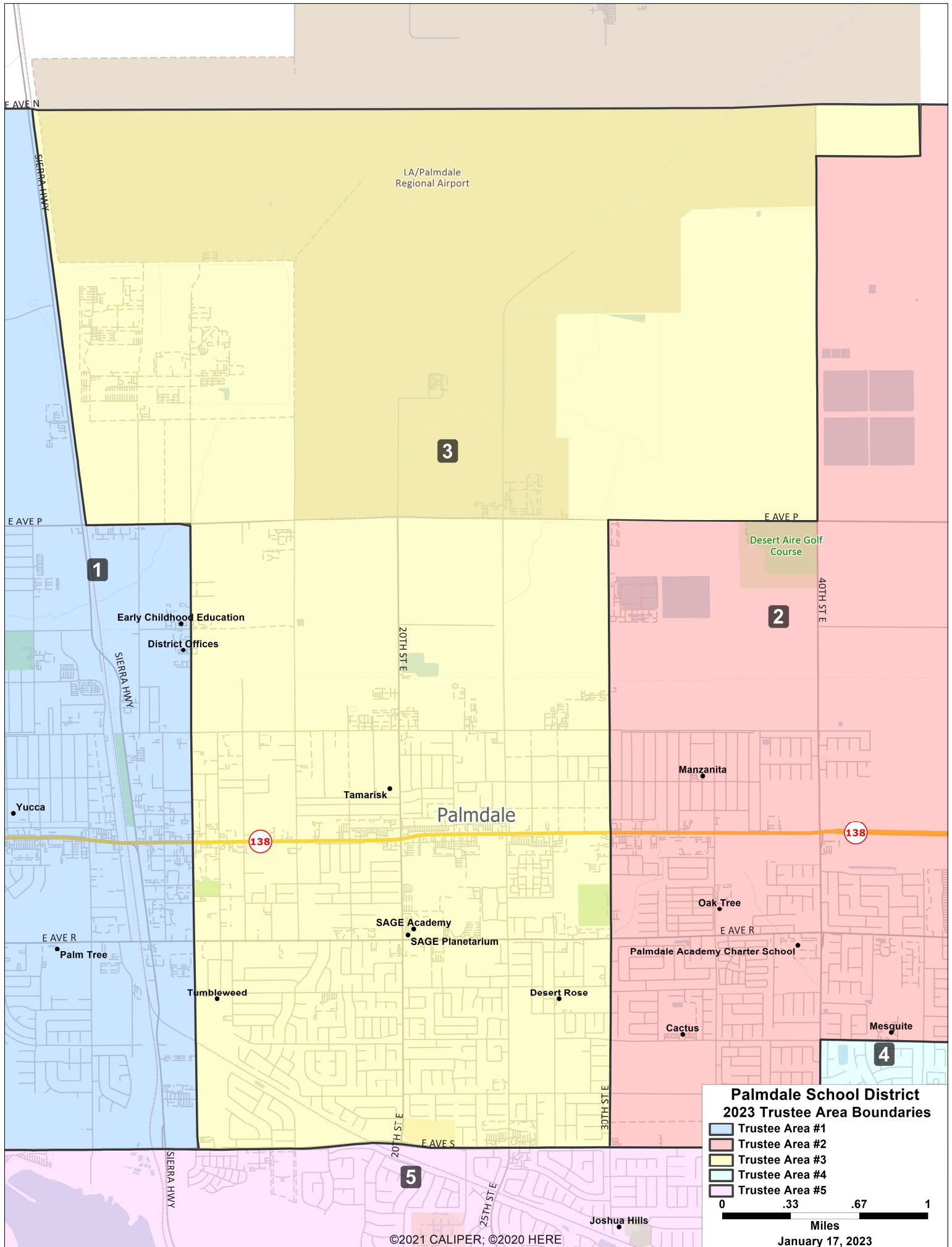

The region bounded and described as follows: Beginning at the point of intersection of Elizabeth Lake Rd and the District boundary, and proceeding northerly and easterly along the District boundary to the Southern Pacific RR, and proceeding southerly along the Southern Pacific RR to E Ave P, and proceeding easterly along E Ave P to 10th St E, and proceeding southerly along 10th St E to E Ave S, and proceeding westerly along E Ave S to State Rte 14, and proceeding northerly along State Rte 14 to W Ave Q, and proceeding westerly along W Ave Q to W Palmdale Blvd, and proceeding westerly along W Palmdale Blvd to Elizabeth Lake Rd, and proceeding westerly along Elizabeth Lake Rd to the point of beginning.

Second Trustee Area.

The region bounded and described as follows: Beginning at the point of intersection of the E Ave P and 30th St E, and proceeding easterly along E Ave P to 40th St E, and proceeding northerly along 40th St E to the southern edge of Census Block 060379800041005, and proceeding easterly and northerly along the edge of Census Block 060379800041005 to the District boundary, and proceeding easterly and southerly along the District boundary to E Palmdale Blvd, and proceeding westerly along E Palmdale Blvd to 60th St E, and proceeding southerly along 60th St E to E Ave R, and proceeding westerly along E Ave R to 55th St E, and proceeding southerly along 55th St E to E Ave R-8, and proceeding westerly along E Ave R-8 to 40th St E, and proceeding southerly along 40th St E to E Ave S, and proceeding westerly along E Ave S to 30th St E, and proceeding northerly along 30th St E to the point of beginning.

Third Trustee Area.
